

## **Appeal**

AZAAN INTERNATIONAL SCHOOL, established in the year 2006 in the plush Banjara Hills area of Hyderabad City is the only exemplary international school, in the State of Andhra Pradesh, India, imparting Modern education with CBSE syllabus with a full-fledged Department of Islamic Studies having 15 Ulema/ Huffaz, providing an environment in which the pupil learns, understands and practises Islam as his way of life, within the parameters of Quran and Sunnah.

The School starting, initially with 53 students, recorded a phenomenal growth and now has a total strength of around 1000 pupils. In spite of this staggering success, the School has not been able to come out of the red, because of the extremely high rent that we are required to pay monthly for our school building situated in the most prime location of the city.

Chairman Dr. Mohammed Yousuf Azam and Managing Trustee Dr. Nayyar Farozan, Founder Trustees of ANWAR CHARITABLE TRUST (which runs the School), donated 10 plots of 700 sq. yds each, the current value of which is not less than 14 crore rupees. Since this land is situated in the development corridor, between the Outer and Inner Ring Roads, the value of the land is expected to further escalate in the near future.

We have got a project prepared for construction of a school building on this land, so that we are able to shift the school from the present leased premises to our own building, to enable us to be relieved of the huge liability in the form of high rent of about 1.5 crores per annum. This amount, thus saved, can be utilised for repayment of the interest-free loan, which we plan to raise for construction of our own building. The cost of the project is 11.27 crores, of which the first phase would cost us approximately 4 crores.
